Pursuant to Section 1901.14(A)(4) of the Ohio Revised Code, the Berea Municipal Court herewith submits its 63rd Annual Report for the year 2021. The contents of this report are based on data assembled and tabulated by Raymond J. Wohl, the Clerk of Courts and his staff of Deputy Clerks. This report reflects the financial and statistical activity of the Court in detail with respect to all political subdivisions within the Court district.

The Berea Municipal Court has been located in the City of Berea, by an act of the Ohio Legislature, since 1958. The Court district boundaries cover an area of 60.8 square miles and have a total population of 122,993 (per 2020 U.S. Census).

The Court serves the cities of Berea, Brook Park, Middleburg Heights, Olmsted Falls, Olmsted Township, Strongsville, in addition to the Ohio Turnpike (Ohio State Patrol) in Strongsville, Berea, and Olmsted Township; Interstate 71 (Ohio State Patrol) in Brook Park, Middleburg Heights, and Strongsville; and the Cleveland Metropolitan Park System within the Berea Municipal Court's boundaries.

Dear Ladies and Gentlemen,

It is with great pleasure that we present to you the 2021 Berea Municipal Court Annual Report as required by O.R.C. §1901.14. This report is our 63rd such Annual Report.

The following are highlights for the year 2021:

Our Traffic/Criminal Department opened a total of 6,649 cases which consisted of 4,594 Traffic cases, 1,243 Misdemeanors, and 446 Felony cases.

The Civil Department processed 2,538 new cases consisting of 1,568 Civil cases with a maximum limit of \$15,000 by statute, 528 Small Claims with a maximum limit of \$6,000 and 442 Eviction cases. In addition to these Civil cases, the Clerk of Courts Office processed 901 Garnishment of Wages and 99 Bank Attachments on cases previously adjudicated.

The COVID-19 Pandemic continued to present a great challenge to our Court as well as all law enforcement agencies within our District. This challenge is evidenced by the number of cases, both Civil and Traffic/Criminal, filed in 2021.

The Court continues to face the challenge of collecting outstanding Court costs and fines from defendants with hardship for payment. To assist the Court with these long past due cases, the Berea Municipal Court contracted with the Attorney General of Ohio (AGO) to assist with case collections. While we exhausted all efforts to work with case defendants through in person and online payment arrangements, the AGO returned in excess of \$200,000 related past due case balances.



2021 COMMUNITY CONTROL DEPARTMENT OVERVIEW

The Berea Municipal Court Community Control Department provides a variety of services to the court and the offenders referred for monitoring. As directed by the Judge an offender may be referred for pre-sentence investigation reports, these reports are used by the court to determine the appropriate sentence, with the goal to minimize the recidivism of the offender and protect the public. The department staff monitors offender's compliance with the courts required sentence and aid offenders in completing these requirements. In addition to the monitoring of sentenced offenders the Community Control Departments monitors the bond conditions of high- risk offenders with the use of; Continuous Alcohol Monitoring Device (CAM), Global Position Tracking Device (GPS) and Pre-Trial Supervision.

The Community Control Department staff oversee four Diversion Programs. The Substance Abuse Intervention In lieu of Conviction Program (SA/ILC), this program targets offenders in need of substance abuse treatment when their use of drugs and/or alcohol were the primary contributing factor that led to the charge(s). The Theft Diversion program targets specific intervention programming to participants to prevent, eliminate, or reduce the rate of recidivism among the programs' participants and promote the collection of restitution to the victim(s). The DUS Diversion program assists the defendants in obtaining a valid driver's license. The First Offender program works with low risk, non-violent, first-time offenders, to educate each participant on the effects of their actions and to prevent the defendant from reoffending.

A total of 1,291 cases were assigned to be supervised by the Community Control Department for either reporting/non-reporting probation or for a pre-sentence investigation to be conducted. In addition to the 1,291 cases referred to Community Control 191 cases were referred to one of the four Diversion Programs.
