Pursuant to Section 1901.14(A)(4) of the Ohio Revised Code, the Berea Municipal Court herewith submits its 65th Annual Report for the year 2023. The contents of this report are based on data assembled and tabulated by Joseph C. DeMio, the Clerk of Courts and his staff of Deputy Clerks. This report reflects the financial and statistical activity of the Court in detail with respect to all political subdivisions within the Court district.

The Berea Municipal Court has been located in the City of Berea, by an act of the Ohio Legislature, since 1958. The Court district boundaries cover an area of 60.8 square miles and have a total population of 122,993 (per 2020 U.S. Census).

The Court serves the cities of Berea, Brook Park, Middleburg Heights, Olmsted Falls, Olmsted Township, Strongsville, in addition to the Ohio Turnpike (Ohio State Patrol) in Strongsville, Berea, and Olmsted Township; Interstate 71 (Ohio State Patrol) in Brook Park, Middleburg Heights, and Strongsville; and the Cleveland Metropolitan Park System within the Berea Municipal Court's boundaries.

Dear Ladies and Gentlemen:

It is with great pleasure that we present to you the 2023 Berea Municipal Court Annual Report as required by O.R.C. 1901.14. This report is our 65th such Annual Report. The content of this report includes data assembled by Clerk of Court Raymond J. Wohl and the Berea Municipal Court Community Control Department. The following are highlights for the year 2023:

Our Traffic/Criminal Department opened a total of 8,421 cases which is a 9.5% increase over 2022. These cases consist of 6,371 traffic cases, 1,369 criminal misdemeanors, 305 felony cases and 376 OVI (Operating Vehicle Under the Influence).

The Civil Department processed 3,118 new cases which is a 17.8% increase over 2022. These cases consist of 1,760 civil cases with a maximum limit of \$15,000 by statute, 803 small claims cases with a maximum limit of \$6,000 and 555 eviction cases. In addition to these civil cases, the Clerk of Courts Office processed 1,002 wage garnishments and 306 bank attachments on cases previously adjudicated.

The Berea Municipal Court continues its relationship with the Attorney General of Ohio (AGO) for collecting outstanding Court costs and fines from defendants. In addition to working with defendants who agree to payment arrangements, the Court forwards uncollectable cases to the AGO for assistance with recovery. Since forming this partnership in late 2020, the AGO has recovered nearly \$661,000 from delinquent defendants.



SECTION FIVE COMMUNITY CONTROL

2023 COMMUNITY CONTROL DEPARTMENT OVERVIEW

The Berea Municipal Court Community Control Department provides a variety of services to the court and the offenders referred for monitoring. As directed by the Judge an offender may be referred for pre-sentence investigation reports. These reports are used by the court to determine the appropriate sentence with the goal to minimize the recidivism of the offender and protect the public. The department staff monitors offenders' compliance with the court's required sentence and aid offenders in completing these requirements. In addition to the monitoring of sentenced offenders the Community Control Department monitors the bond conditions of high- risk offenders with the use of Continuous Alcohol Monitoring Device (CAM), Global Position Tracking Device (GPS) and Pre-Trial Supervision.

The Community Control Department staff oversees four Diversion Programs. One such program is the Substance Abuse Intervention in Lieu of Conviction Program (SA/ILC). This program targets offenders in need of substance abuse treatment when their use of drugs and/or alcohol were the primary contributing factor that led to the charge(s). The 2nd program, called the Theft Diversion Program, targets specific intervention programming to participants to prevent, eliminate, or reduce the rate of recidivism among the program's participants and promote the collection of restitution to the victim(s). The 3rd program, called the DUS Diversion Program, assists the defendants in obtaining a valid driver's license. Lastly, the First Offender Program works with low-risk, non-violent, first-time offenders to educate each participant on the effects of their actions and to prevent the defendant from reoffending.
