

prohibited from removing or attempting to remove such money, property, or credits until expressly permitted by the Court. Any violation of this prohibition subjects you to punishment from contempt of Court.

The law of Ohio and the United States provides that certain benefit payments cannot be taken from you to pay a debt. Typical among the benefits that cannot be attached or executed upon by a creditor are:

There may be other benefits not included in the above list that apply in your case. If you dispute the Judgment Creditor's right to gamish your property and believe that the judgment creditor should not be given your money, property, or credits, other than personal earnings, now in the possession of the indicated gamishee because they are exempt or if you feel that this order is improper for any other reason, you may request a hearing before this Court by disputing the claim in the request for hearing form, appearing on the reverse side, or in a substantially similar form, and delivering the request for hearing to this Court at the above address, at the office of the Clerk of this Court no later than the end of the fifth business day after you receive this notice. You may state your reasons for disputing the Judgment Creditors right to garnish you property in the space provided on the form but you are not required to do so. If you do state your reasons for disputing the Judgment Creditor's right, you are not prohibited from stating any other reason at the hearing, and if you do not state your reasons, it will be held against you by the Court and you can state your reasons at the hearing. NO OBJECTIONS TO THE JUDGMENT ITSELF WILL BE HEARD OF CONSIDERED AT THE HEARING If you request a hearing, the hearing will be limited to a consideration of the amount of your money, property, or credits, other than personal earning, in the possession of control of the indicated gamishee, if any, that can be used to satisfy all or part of the judgment you owe to the judgment Creditor. If you request a hearing no later than the end of the fifth business day after you received this notice, it will be conducted at

You may request the Court to conduct the hearing before this date by indicating 20 At M. on your request in the space provided on the form: the Court then will send you notice of any change in the date, time, or place of the hearing. If you do not request a hearing by delivering your request for hearing no later than the end of the fifth business day after you receive this notice, some of your money, property, or credits, other than personal earnings, will be paid to the Judgment Creditor.
